COMPETITION GUIDELINES

THE COMPETITION

The Atlanta Community Symphony Orchestra Ruth Kern Young Artists Concerto Competition, under the auspices of the Atlanta Music Club, a non-profit organization, is open to all young musicians from the Southeast. Students may compete on any symphonic instruments, piano, guitar, and voice.

The competition has three divisions, Junior, Senior, and Undergraduate/Graduate. The Junior Division is open to applicants 14 years of age and below. The Senior Division is open to applicants 15-18 years of age. The Undergraduate/Graduate Division is open to currently enrolled undergraduate and graduate college students. (See eligibility for Junior, Senior, and Undergraduate/Graduate Divisions.)

The winners of Atlanta Community Symphony Orchestra Ruth Kern Young Artists Concerto Competition will have the opportunity to perform with the Atlanta Community Symphony Orchestra at its spring concert of the 2012-2013 concert season, scheduled for Sunday, March 17th, 2013 at 4:00 p.m. and/or Sunday, March 24th, 2013.

All instrumentalists from the Junior, Senior or College Undergraduate/Graduate Division must select a concert piece or single movement from the standard concerto repertoire. Double and triple concertos are acceptable; Vocalists are required to select two (2) contrasting arias.

ELIGIBILITY

JUNIOR DIVISION:

- 14 years of age and below
- To be eligible, participants must not have reached their 15th birthday by May 17, 2013.

SENIOR DIVISION:

- 15 to 18 years of age
- To be eligible, participants must not have reached their 19th birthday by May 17, 2013.

UNDERGRADUATE/GRADUATE DIVISION:

- Current Undergraduate or Graduate Student
- Must present valid college ID

OTHER ELIGIBILITY REQUIREMENTS:

- Previous winners of the ACSO—YACC are not eligible to compete within consecutive years.
- The competition is open to U.S. citizens, legal U. S. residents and students with an INS visa who are residents of Georgia, Florida, Alabama, Tennessee, or South Carolina.
- Applicants must include a signature of endorsement from their private teacher.

APPLICATION PROCESS

- A completed printed application form, along with the required enclosures, application fee and preliminary audition CD, must be sent to:

- A copy of the applicant's birth certificate, driver's license, driving permit, state identification (or other official document demonstrating the age of the applicant) or a copy of a valid college ID must accompany the application form.
- A copy of the INS status must accompany the application if the applicant holds a student visa.
- A non-refundable application fee of \$50, **PAYABLE TO: ATLANTA COMMUNITY SYMPHONY ORCHESTRA (ACSO)**, must be enclosed with the application.
- **NOTE:** An incomplete or illegible application will not be considered.
- Please double check your recordings! We have received CDs in the past that could not be heard.
- **Applications must be postmarked no later than WEDNESDAY, JANUARY 23RD, 2013.**

REPERTOIRE

- All instrumentalists from the Junior, Senior or College Undergraduate/Graduate Division must select a concert piece or single movement from the standard concerto repertoire and/or character piece with an orchestral accompaniment. Double and triple concertos are acceptable.

AUDITION REQUIREMENTS

- All applicants must submit with the application a preliminary audition CD of their selection(s).
- **CD CASES ONLY** must be clearly marked with the applicant's name, age, address, phone number, instrument, works recorded, and date recorded. **DO NOT LABEL THE ACTUAL CD ITSELF.**
- **The CD itself must NOT be labeled with any information identifying the applicant.**
- Professional-quality recording is suggested but not required.
- CDs will not be returned.
- Applicants are strongly encouraged to send CDs via traceable mail and to make copies in case of loss in transit.

FINALS

- Applicants will be notified by e-mail of their acceptance to the finals no later than **Wednesday, January 30th, 2013.**
- Finals will be on **Saturday, February 2nd, 2013** starting at 10:00 a.m. at Peachtree Presbyterian Church in Buckhead. (driving directions will be e-mailed to competitors)
- All finalists are required to play from memory the same selection(s) submitted for Preliminaries on their recording.
- Finals will be judged by a panel of professional musicians, appointed by the Music Director.
- Finalists will be assigned a 15 minute plus time according to their instrument and/or selected repertoire, and will be required to arrive at least 15 minutes before their audition time. Finalists should be prepared to perform different portions of their selection(s) as requested by the judges.
- Each finalist must provide their own accompanist. (Pianists do **NOT** need an accompanist.)
- The judges' decision is final. Scores and comments will not be made available.
- If no applicant qualifies (in one or any division), judges will not be required to nominate a winner.
- Winners will be notified by e-mail, no later than **Wednesday, February 6th, 2013.**
- **MANDATORY** Rehearsal and Dress Rehearsal are scheduled for **Tuesday, March 12th, 2013** at 7:30 p.m. and **Saturday, March 16th, 2013** at 10:00 a.m.

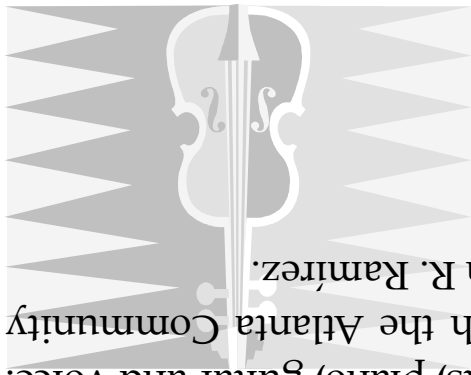

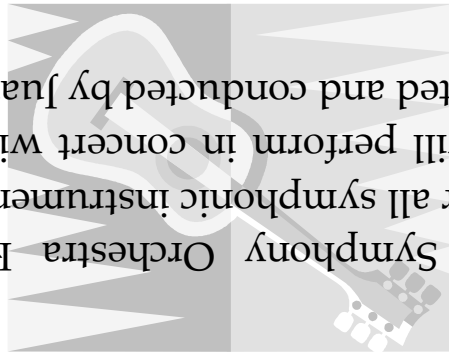
